1. **Terms and Conditions and their acceptance:** Information on how to enter this promotion, the prize(s) forming part of this promotion, and other rules governing the conduct of this promotion are set out in these terms and conditions (“**Terms and Conditions**”). Participation and submitting an entry in this promotion is deemed acceptance of these Terms and Conditions.
2. **Ineligible persons:** Employees (and their immediate families) of the Promoter and agencies (and their immediate families) and other third parties (and their immediate families) associated with this promotion are ineligible to enter. 3. **Invalid entries:** Incomplete or indecipherable entries will be deemed invalid.
4. **Promoter rights to reject and verify:** Without limiting the Promoter’s other rights, the Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Late or misdirected entries, or any other errors and omissions, may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved. 6. **Decision is final:** The Promoter’s decision is final and binding, and no correspondence will be entered into.
7. **Forfeited prizes:** If for any reason a winner does not take a prize (or an element of a prize) at/by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
8. **Unavailable prizes:** If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize of the equal value and/or specification.
